The first chart below provides certain information regarding franchised Fitness Studios in operation at the end of the 2025 calendar year. The information is categorized by revenue into three categories: the Top 20% of franchised Fitness Studios by revenue (the “Top 20%”), the middle 60% of franchised Fitness Studios by revenue (the “Middle 60%”); and the lower 20% of franchised Fitness Studios by Revenue (the “Lower 20%”). The first chart displays the Average Revenue, Median Revenue, High Revenue and Low Revenue with respect to each category for 2025. All franchised locations that were open at the end of 2025 are included in the first chart unless the location was not open for at least ten months during 2025. 76 franchised locations are included in the first chart. Two franchised locations that were in operation at the end of 2025 were excluded from the first chart below and their information is provided in the second chart. Information for the ten company-owned locations that were in operation at the end of 2025 is provided in the third chart. Fifteen franchised locations closed in 2025 prior to the end of 2025; they are not included in the charts because they were not in operation at the end of 2025.
