**ITEM 19**  
**FINANCIAL PERFORMANCE REPRESENTATIONS**

The FTC's Franchise Rule permits a franchisor to provide information about the actual or potential financial performance of its franchised and/or franchisor-owned outlets, if there is a reasonable basis for the information, and if the information is included in the disclosure document. Financial performance information that differs from that included in Item 19 may be given only if: (1) a franchisor provides the actual records of an existing outlet you are considering buying; or (2) a franchisor supplements the information provided in this Item 19, for example, by providing information about possible performance at a particular location or under particular circumstances.

The following Tables present certain historical financial information for franchised Golden Corral Restaurants. The Tables exclude franchised Restaurants using a building design other than the GC-11S and GC-11M, because only those two designs have been available to new franchisees for the last several years (see Item 1). We had a total of 352 franchised Restaurants in operation at the end of our fiscal year on January 3, 2024, including Restaurants with other building designs.

The explanatory notes accompanying the Tables are an important part of the information presented.

Table 1 below provides the average gross sales, selected expenses, and operating income for fiscal year 2023 (the period December 28, 2022 through January 3, 2024) and fiscal year 2022 (the period from December 30, 2021 through December 28, 2022) for franchised Restaurants utilizing the GC-11M building design. Table 1 excludes 3 GC-11M franchised Restaurants that had been in operation for less than 6 months as of January 3, 2024.
