Our Fremont outlet was transferred from our affiliate to a franchisee in February 2024 and is located at 44029 Osgood Rd. #140, Fremont, CA 94539. Our Campbell outlet opened October 2024 and is located at 1700 W.Campbell Ave., Campbell, CA 95008. Our Campbell outlet is not included since they have been open for less than a year.
