

ITEM 19. FINANCIAL PERFORMANCE REPRESENTATIONS

The FTC's Franchise Rule permits a franchisor to provide information about the actual or potential financial performance of its franchised and/or franchisor-owned outlets, if there is a reasonable basis for the information, and if the information is included in the disclosure document. Financial performance information that differs from that included in Item 19 may be given only if: (1) a franchisor provides the actual records of an existing outlet you are considering buying; or (2) a franchisor supplements the information provided in this Item 19, for example, by providing information about possible performance at a particular location or under particular circumstances.

We have included below a historic financial performance representation setting forth Gross Revenues information for existing Squeegee Squad franchised Businesses and an affiliate-owned Business that had been open and continuously operating in the U.S. on a full-time basis for at least one full calendar year as of December 31, 2024 ("Qualifying Businesses").

The figures shown are unaudited results that Qualifying Businesses reported to us for operations in the 2024 calendar year.

In Section A below, the information discloses the annual Gross Revenue of each Qualifying Business, and the total population of each Qualifying Business's Territory(ies).

In Section B below, the information discloses the annual difference in percent of total systemwide Gross Revenues from 2023 and 2024 for all franchise Qualifying Businesses that were open and operating for at least two full years as of December 31, 2023. Section B excludes the affiliate-owned Qualifying Business.

For purposes of this Item 19, "Gross Revenues" means all income of the reported Qualifying Businesses from the sale of services and products, by both cash and credit. Gross Revenues does not include any sales, use or gross receipts taxes if the amount of the tax was added to the selling price, charged to the customer, and paid to the appropriate taxing authority. Gross Revenues are reported for the applicable period using cash basis accounting.

Written substantiation of the data contained in this financial performance representation will be made available to you upon reasonable request. We do not otherwise furnish to prospective franchisees any oral or written information concerning the actual or potential sales, income or profits of a Squeegee Squad Business.

Section A. Annual Gross Revenue Based by Qualifying Business

As of December 31, 2024, there were 65 franchised Squeegee Squad Businesses operating in 70 territories and one Squeegee Squad Business operated by our affiliate. The table below includes data from 60 franchised Squeegee Squad Businesses operating in 65 territories and one Squeegee Squad Business operated by our affiliate. 5 franchised Squeegee Squad Businesses were excluded from the below financial performance representations because those businesses were not operated on a full-time basis during 2024. Also excluded from this Item 19 are 4 franchised businesses that ceased operations in 2024. We also exclude from this Item 19 one affiliate-owned Squeegee Squad business because that business is not operated in the same manner as a franchised Squeegee Squad business.

Section B. Change in Percent of Systemwide Gross Revenues from 2023 to 2024 for Franchise Qualifying Businesses

The table below shows the difference in percent of total systemwide Gross Revenues between all franchised Squeegee Squad Businesses operating in 2024 and all franchised Squeegee Squad Businesses operating in 2023. The change in percent was calculated by aggregating the 2024 Gross Revenue of all franchised Squeegee Squad Businesses operating in 2024 and dividing it by the aggregate 2023 Gross Revenue of all franchised Squeegee Squad Businesses operating in 2023.
