## **ITEM 19 FINANCIAL PERFORMANCE REPRESENTATIONS**

The historical financial performance representation below reflects the performance for some of our franchised outlets. All tables below reflect the average Gross Revenue. To be included in these Disclosures, a franchise location had to be (1) open for business for at least the last 6 months of the calendar year 2024 and, (2) generally, have at least one Principal owner operating the franchised business on a full-time basis (see note 1 directly following the tables below). Of the 33 franchisees that were open on December 31st, 2024, 1 was excluded from this disclosure as it had not been operating for the minimum required time. 13 were excluded as they were not, to the best of our knowledge, operating their business on a full-time basis. 4 were excluded as they are currently in inactive status (see note 2 directly following the tables below). The remaining franchisees are presented based on how long they have been in business.

Group 1 (Table 1), which represents franchisees who had been in business for 3 or more years as of December 31st, 2024, contains 12 franchisees that were operating a P3 business as of that date;

Group 2 (Table 2), which represents franchisees who had been in business, at least 2 but less than 3 years as of December 31st, 2024, contains 3 franchisees that were operating a P3 business as of that date;

Group 3 (Table 3), which represents franchisees that had been in business at least 6 months but less than 2 years as of December 31st, 2024, contains 1 franchisee that was operating a P3 business as of that date;
