ITEM 18 PUBLIC FIGURES

ITEM 19 FINANCIAL PERFORMANCE REPRESENTATIONS

The FTC's Franchise Rule permits a franchisor to disclose information about the actual or potential financial performance of its franchised and/or franchisor-owned outlets, if there is a reasonable basis for the information, and the information is included in the disclosure document. Financial performance information that differs from that included in ITEM 19 may be given only if: (1) a franchisor provides the actual records of an existing outlet you are considering buying; or (2) a franchisor supplements the information provided in this ITEM 19, for example, by providing information about performance at a particular location or under particular circumstances.

The tables below summarize the financial performance of all Big Air Trampoline franchised locations open and operating during all twelve months during the period of January 1, 2024 and December 31, 2024 ("Reporting Period"). These 10 franchised locations have been in operation for an average of 3 years and 9 months. Specifically, the information in the tables below represents the revenue and expenses reported by the franchisees during a 12-month operating period. The information in the tables below is organized into three tiers of franchised locations, Tier 1, Tier 2 and Tier 3.

For purposes of this ITEM 19, “Gross Revenue” is defined as the total of all receipts derived from services performed or products sold at the Big Air Trampoline franchised location, whether such receipts are evidenced by cash, credit, checks, gift certificates, scrip, coupons, services, property or other means of exchange and does not include the following: (i) sales tax receipts collected by the Big Air Trampoline franchisee and paid to the government or any governmental authority; (ii) promotional or discount coupons to the extent that the Big Air Trampoline franchisee received no revenue; and (iii) the receipt of services or products by any employee of the Big Air Trampoline franchisee to the extent of the discount offered to the employee or such services or products were delivered to the employee for no charge.

“Expenses” include operating expenses, insurance, utilities, marketing, rent, payroll, retail supplies, taxes and royalties.

(2) Franchisees must receive approval from us before selling any product or service other than our authorized products or services. Therefore, your income from miscellaneous sources may not be similar to those of the Big Air Trampoline franchisees disclosed above.

(3) The information used to prepare the Tables above was prepared from the profit and loss

statements generated by our franchisees' internal accounting systems. We do not know of any instance, nor do we have reason to believe that our franchisees would overstate or understate the franchisee's revenues or expenses.

(4) **Some franchised locations have earned these amounts. Your individual results may differ. There is no assurance that you will earn as much.**

We also do not authorize our employees or representatives to make any such representations either orally or in writing. *In 2022, one of our franchisees purchased three non-Big Air trampoline parks in Colorado, Ohio, and Washington with the intent to convert them to Big Air outlets. Previously, we had categorized each of these three trampoline parks as "Outlets Opened" in 2022; however, the Colorado outlet never reopened as a Big Air outlet, so we have removed that outlet completely from Item 20.

**For purposes of this Table No. 1, we include the two Big Air Trampoline Facilities owned by our affiliates, Big Air Fun, LLC and Big Air Buena Park, LLC, as "Company-Owned" units.
