ITEM 19. FINANCIAL PERFORMANCE REPRESENTATIONS

The FTC's Franchise Rule permits a franchisor to provide information about the actual or potential financial performance of its franchised and/or franchisor-owned outlets, if there is a reasonable basis for the

information, and if the information is included in the disclosure document. General Notes About Businesses Represented

As of December 31, 2024, there were 41 SkyRun franchised Businesses in the SkyRun franchise System and 7 affiliate-owned Businesses. In the tables below we have provided certain historical information related to the 33 franchised and 7 affiliate-owned Businesses that operated for the entire 12-month period ended December 31, 2024. We excluded 8 franchised Businesses that began operating in 2024 and therefore had not operated for the entire 12-month period ended December 31, 2024. 2 of the franchised Businesses include 2 “Designated Territories” each but aggregate all data. The affiliate-owned Businesses include 1 affiliate-owned Business that, for purposes of Item 20 opened in January 2024, but acquired certain properties under management from a former franchised Business that opened as a franchise in December 2022 and therefore we consider as operating for the entire 12-month period ended December 31, 2024 for purposes of Item 19. None of these franchised Businesses closed before operating for at least 12 months. None of these affiliate-owned Businesses closed before operating for at least 12 months.

General Notes About Statements Presented

We have broken this historical information into two charts below. With respect to each chart we have provided information related to the following subsets (as disclosed below): (i) those franchised Businesses that had operated for at least 12 months but less than 24 months as of December 31, 2024 (“New Businesses”); (ii) those franchised Businesses that had operated in the SkyRun System for 24 months or longer as of December 31, 2024 (“Experienced Businesses”); and (iii) the affiliate-owned Businesses, all of which had operated for longer than 24 months as of December 31, 2024. There were 18 New Businesses and 15 Experienced Businesses.

The affiliate-owned Businesses opened between April 2004 and January 2024 (however, as disclosed above, this most recent affiliate-owned Business acquired certain properties under management from a former franchised Business that opened as a franchise in December 2022). The New Businesses opened between February 2023 and December 2023. The Experienced Businesses opened between May 2009 and December 2022. Some of the franchised Businesses had converted from licensees of our predecessor to franchisees in our System. All of these Businesses offered substantially similar services and products to those offered by our franchise System. All of the information disclosed below is for the time period beginning January 1, 2024 and ending December 31, 2024.
