

ITEM 19 **FINANCIAL PERFORMANCE REPRESENTATIONS**

The FTC's Franchise Rule permits a franchisor to disclose information about the actual or potential financial performance of its franchised and/or franchisor-owned outlets, if there is a reasonable basis for the information, and the information is included in the Disclosure Document. Financial performance information that differs from that included in Item 19 may be given only if: (1) a franchisor provides the actual records of an existing outlet you are considering buying; or (2) a franchisor supplements the information provided in this Item 19, for example, by providing information about possible performance at a particular location or under particular circumstances.

As of December 31, 2024, we had a total of 20 franchised AR Businesses, one company-owned AR Business, four AR Business owned by our employees and 202 Assisting Hands Business franchises. Of the 202 Assisting Hands Business franchises, 120 were supported by AR Businesses.

The information in the tables below is a historical financial performance representation of the franchised AR Businesses that (i) were in operation for 12 months or longer for each calendar year and (ii) supported at least one Assisting Hands Business franchise (“Reporting Group”) for the entire calendar year (“Reporting Period”). We have not included the affiliate-owned AR Business in the Reporting Group, two AR Businesses that weren’t open a full year as of December 31, 2024 (Missouri and SE Pennsylvania) and two AR Businesses that did not have any franchised Assisting Hands Businesses in their Territory (Indiana and South Michigan).

Notes:

1. For purposes of this Item 19, the term “AR Royalty” means the amounts we pay to AR Businesses for commissions for revenues we receive from third-party franchisees that purchase Assisting Hands Business franchises in a Development Territory. This is calculated as 50% of the royalty fee we receive from franchisees.

2. The financial performance representations above do not reflect the costs of sales, operating expenses, or other costs or expenses that must be deducted from the gross revenue or gross sales figures to obtain your net income or profit.

3. The Reporting Group includes two AR Businesses owned by employees of the franchisor.

4. Area Representatives territory size varies depending on the geographic location. The financial performance information in this Item 19 presents per AR Business averages regardless of territory size. AR Businesses with larger territories may receive higher AR Royalties than AR Businesses with smaller territories. The Table below provides territory information on each of the 20 AR Businesses in the 2024 Reporting Group. We have not included the AR Business in Indiana because it doesn’t have any Assisting Hands Businesses in its Development Territory and therefore does not receive any AR Royalties.
