Financial Performance Representations

The FTC's Franchise Rule permits a franchisor to provide information about the actual or potential financial performance of its franchised and/or franchisor-owned outlets, if there is a reasonable basis for the information, and if the information is included in the disclosure document. As of December 31, 2024, there were 42 franchisees operating 84 Offices. These 84 Offices do not include 5 franchised offices that permanently closed during the 2024 calendar year. Of these 84 Offices, we have excluded (i) 8 Offices that opened during the 2024 calendar year and did not operate for the entire 2024 calendar year, and (ii) 5 Offices that operate as satellite offices offering limited services focused on in-person recruiting. The remaining 71 of the 84 franchised Offices operated as standard Offices during the entire 2024 calendar year. As of December 31, 2024, there were 6 affiliate-owned Offices that operated for the entirety of the 2024 calendar year. In this Item 19, we provide below, for calendar year 2024, the following statistics for the 71 franchised Offices and 6 affiliate-owned Offices: (1) Gross Revenue; (2) Hours Billed; (3) Gross Profits; and (4) Gross Margins.

Notes

Note (1) – The term “Gross Revenue” as used in this Item 19 means all revenue or consideration that a franchisee receives, directly or indirectly, from operating its Office, whether from cash, check, credit and debit card, barter exchange, trade credit, or other credit transactions. Gross Revenue includes the proceeds of any business interruption insurance or similar insurance. Gross Revenue does not include any federal, state, or municipal use or service taxes collected from customers and paid to the appropriate taxing authority. The term “Gross Revenue” as used in this Item 19 has the same meaning as in your Franchise Agreement.

Note (2) – The term “Hours Billed” as used in this Item 19 means all hours billed for Assigned Temporary Workers placed on assignment by the Personnel Services Business during the 2024 calendar year.

Note (3) – The term “Gross Profits” as used in this Item 19 means an Office’s Gross Revenue, less its payroll expenses and taxes.

Note (4) – The term “Gross Margin” as used in this Item 19 means the Gross Profits of an Office as a percentage of its Gross Revenue.

Written substantiation for the financial performance representation will be made available to the prospective franchisee upon reasonable request. Information appearing in the tables about the franchised outlets comes from franchisee reports to us.

Some outlets have earned this amount. Your individual results may differ. There is no assurance that you'll earn as much.

Other than the preceding financial performance representation, AtWork Franchise, Inc., does not make any financial performance representations. We also do not authorize our employees or representatives to make any such representations either orally or in writing. If you are purchasing an existing outlet, however, we may provide you with the actual records of that outlet.
