

ITEM 19 **FINANCIAL PERFORMANCE REPRESENTATIONS**

The FTC's Franchise Rule permits a franchisor to provide information about the actual or potential financial performance of its franchised and/or franchisor-owned outlets, if there is a reasonable basis for the information, and if the information is included in the disclosure document. Financial performance information that differs from that included in Item 19 may be given only if: (1) a franchisor provides the actual records of an existing outlet you are considering buying; or (2) a franchisor supplements the information provided in this Item 19, for example, by providing information about possible performance at a particular location or under particular circumstances.

FPR #1-Affiliate Earnings

Here, we set forth the Gross Revenues and Adjusted Earnings Before Tax, Interest, Depreciation and Amortization for our sole affiliate outlet, Dumpster Dudez, LLC, located in Berks, PA, for the 2020 - 2024 calendar years:

There are material operational differences between the company outlet whose results are reported in the table above and a franchise outlet that a franchisee would operate. The company outlet has operated since 2017. Further, the company outlet serves a territory containing approximately 208,000 single family dwelling units

In addition, there are financial differences. A franchised outlet would incur Royalties. So we impute those costs in the tables above under the category, "7% Royalty Adjustment."

And a franchised outlet would likely incur a monthly Local Advertising spend of \$1,000 - \$3,000. We do not make a further adjustment for this cost as the affiliate company store normally spent this amount or more and such expense is already included in the "Expenses Before Tax, Interest, Depreciation & Amortization" row in the table above.

We would also note that we do not show a salary or owner's draw in the tables above. If you take a salary or draw, the Adjusted Earnings Before Tax, Interest, Depreciation & Amortization would be reduced by the amount of your salary or draw.

FPR #2-Franchisee Earnings

Here, we set forth the Profit and Loss Statement for our franchised outlets that operated an entire year in either 2021 or 2022, 2023, 2024 or more than one of those years.

As of December 31, 2021, we had 2 franchised outlets, 1 of which had operated the entire 2021 calendar year, and therefore met the criteria for inclusion below.

As of December 31, 2022, we had 8 franchised outlets, 2 of which operated the entire 2022 calendar year, and therefore met the criteria for inclusion below:

As of December 31, 2023, we had 18 franchised outlets, 7 of which operated the entire 2023 calendar year, and therefore met the criteria for inclusion below:

As of December 31, 2024, we had 31 franchised outlets, 17 of which operated the entire 2024 calendar year, and therefore met the criteria for inclusion below:

Expenses Before Tax, Interest, Depreciation & Amortization: means all expenses (except an Owner's Salary or Draw) incurred in operating the business excluding tax, interest, depreciation & amortization. We have removed any owner's salary or draw from the expenses in the tables above.

Earnings Before Tax, Interest, Depreciation & Amortization: represents the income made prior to removing any expenses associated with tax, interest, depreciation or amortization.

7% Royalty Adjustment: is a calculation used to make an adjustment to any location to show numbers all with an equal calculation of 7% royalty rate.

Adjusted Earnings Before Tax, Interest, Depreciation & Amortization: represents the adjusted income after consideration of 7% royalty.

Adjusted Earnings % of Gross Revenues: represents the percent of income compared to sales after all adjustments made.

Some outlets have earned this amount. Your individual results may differ. There is no assurance you will earn as much.

Written substantiation of the financial performance representation will be made available to you upon reasonable request.

Other than the preceding financial performance representation, we do not make any financial performance representations. We also do not authorize our employees or representatives to make any such representations either orally or in writing. If you are purchasing an existing outlet, however, we may provide you with actual records of that outlet.
